1. INTRODUCTION & AGREEMENT TO TERMS

These Terms of Service ("Terms") govern your purchase and use of the STAMP Tier watermark product ("Product") offered by My Human Watermark ("M.H.W", "Company," "we," "us," or "our"), a company incorporated and operating under the laws of the State of California, United States of America.

By completing your purchase of the STAMP Tier product, you affirmatively acknowledge that you have read, understood, and agree to be bound by these Terms (a "clickwrap" agreement).

If you do not agree to these Terms, do not purchase and/or use the Product.

2. PRODUCT OVERVIEW

2.1 STAMP Tier Product Description

The STAMP Tier is a one-time purchase (\$50.00) that provides:

- Universal watermark overlay with My Human Watermark branding
- Two aspect ratio formats: 4:3 and 16:9
- Perpetual usage rights
- Valid proof of purchase documentation
- Basic content protection and content theft deterrent

2.2 What STAMP Tier Is

The STAMP Tier is a standard, non-unique universal watermark overlay designed to serve as a visible ownership marker for your digital content. The watermark provides basic forensic documentation and functions as a content theft deterrent.

2.3 What STAMP Tier Is NOT

The STAMP Tier does not include:

- Custom or unique watermark design
- My Human Watermark verification or authentication services of any kind
- Legal representation or legal advice
- Content authentication support or proof of ownership verification by M.H.W.
- Forensic verification capabilities available in higher-tier products
- Motion-specific files or projects (folders 8 and 9)
- Any guarantee that third-party platforms will recognize or act upon the watermark
- Any obligation by My Human Watermark to participate in legal proceedings, authentication, or removal requests on your behalf

3. PURCHASE INFORMATION

3.1 Price and Payment

- Purchase Price: \$50.00 (one-time payment)
- Payment Terms: Payment is required at the time of purchase

3.2 Proof of Purchase

Your proof of purchase is your only evidence of license and authorization to use the STAMP Tier product. You are solely responsible for maintaining and preserving your proof of purchase including your receipt, transaction confirmation, and any associated documentation indefinitely. You bear the burden of producing proof of purchase if license questions, disputes, or legal proceedings arise.

4. LICENSE GRANT & USAGE RIGHTS

4.1 License Grant

By purchasing the STAMP Tier, you are granted a non-exclusive, non-transferable, worldwide, perpetual license to use the universal watermark overlay provided to you.

4.2 Permitted Uses

You may:

- Apply the watermark overlay to your original images and video content
